Once fully operational, we will maintain data protection and privacy for all Clients in accordance with the laws of every state and in compliance with all data privacy acts (HIPAA).

### **Information We Collect**

We collect two types of data:

a. Personal Data

Information you voluntarily provide, including:

- Name
- Email address
- Phone number
- Address (if required for coverage quotes or client onboarding)
- Payment information (processed securely via third-party services for \$1 registration or policy payment)

#### b. Usage Data

Automatically collected information:

- IP address, browser type, device ID
- Pages visited, time on site, navigation behavior
- Referral source and form submissions

## **How We Use Your Information**

We use your information to:

- Process registration and verify access eligibility
- Provide access to gated materials (e.g., flyer vault, client portal)
- Administer the Bring Your 4 referral program
- Communicate about Better Insurance updates, services, or opportunities
- Comply with legal obligations and insurance regulations
- Monitor site performance and security

We do not sell your information. We do not display ads or share your data with unrelated third parties.

## **Cookies and Tracking**

Our site may use basic cookies for session management, traffic analytics, and login functionality. These do not track your behavior across the internet. By continuing to use the site, you consent to the use of essential cookies.

If we implement analytics tools (e.g., Google Analytics), we will update this policy and provide a cookie notice.

## **Data Retention**

We retain client data only as long as necessary to:

- Fulfill insurance requirements
- Maintain referral histories
- Satisfy legal and regulatory obligations
